Instructions

In-person Voting: Voting will take place at the April 8 General Meeting, the First United Methodist Church, 1376 Olive Street.

Absentee Voting: Members who cannot attend may request an absentee ballot by requesting one from jwneugene@gmail.com.

- Requests must include the member's full name and complete street address. If you are a business
 owner or manager or director of a non-profit with a physical location in the JWN, identify your
 role and provide the name and address of your organization.
- Each absentee ballot must be requested in an individual email even if members live at the same physical location.
- Ballots will be sent as an attached file with an ID number associated with your name and address.
 DO NOT SHARE BALLOTS. Multiple submission using one ID number will invalidate all ballots with that ID number. All absentee ballots will be cross referenced matching the ID number, name, and address.
- Completing Ballots: Ballots require your full name, physical address, and a signature. Members
 may only vote for the candidates listed. If you do not support any candidate for a particular
 position, write NONE.
- Submitting Ballots:
 - Ballots may be dropped off via the mail slot at 971 W. Broadway NO LATER than noon April 8. Ballots submitted should be inside a sealed envelope that will not be open until votes are counted at the April 8 meeting.
 - Ballots must be printed and can be dropped off at the April 8 meeting by the voter or a third party but must be in the possession of the vote counter before the vote counting begins. To be safe, drop off by 6:30pm.

Nomination Process

All Board positions (Chair, Vice Chair, and five member-at-large positions) are open every year. <u>View the JWN Bylaws for details</u>. Call for nominations was sent out via the Winter 2025 Newsletter mailed to every JWN address, posted on our website, and included in the February and March eNews. A Nominating Committee comprised of a Board member and at least two neighbors' reviews applications to ensure candidates qualify.

- March 10: Deadline for candidates to declare their intention to stand for election. Candidates are supplied a candidate information sheet. Candidates should send an email to jwneugene@gmail.com
- March 20: Deadline for candidates to submit required bio and answer candidate questionnaire.
- March 25: Completion and submission of voter's guide.
- March 26: Deadline for publication of voter's guide on JWN website.
- April 1: Ballot is complete and sent for photocopying.
- April 8: General meeting and election.

Position: Chair

Candidate: Ted M. Coopman (Incumbent)

Stephanie and I have been visiting friends in family in Eugene since 1995 and bought a home in the JWN in 2012, moving here full time in 2016. I retired as a faculty member from San Jose State University in 2020. For fun, I grow fruit and veggies, and we can and dry food, take our dog Raven to the park and the beach, and enjoy Broadway in Eugene shows, the symphony, and are patrons of Ballet Fantastique.

Please share any relevant experience that you feel prepares you for this position on the JWN board.

I have over 30 years' experience as an activist and have served on the JWN Board as an at-large member from 2016-2018 and as Chair from 2018 to 2025. As Board member I reactivated the Friends of Monroe Park group and still lead it, advocating for resources and organizing work parties, as well as working to put organized groups in all JWN parks. As Chair I led the effort to build the Ollie Court Affordable Housing Apartments and early learning center at 13th and Chambers, a project the JWN has been advocating for over decade. I was the only neighborhood leader invited to join the Eugene Chamber of Commerce's Business Leaders Task Force on Homelessness. I currently also serve on the Lane Events Center Visioning Work Group and am a Board member for Eugene Neighborhoods Inc.

What are the two main things you hope to accomplish in the coming year if elected to the JWN Board? Continue work on the Historic District Task Force project and disaster preparedness.

I previously served on the Executive Boards of the American Communication Association and the Association of Internet Researchers as well as the steering Committee of the Live Oak Neighbors Association, Live Oak Off-Leash Advocates, and the Santa Cruz Independent Media Center, all in Santa Cruz CA.

Position: Vice Chair

Candidate: Sandra Bishop (Incumbent)

Brief Bio (100-200) words

I came to Eugene originally to attend the University of Oregon and stayed. I grew up east of the mountains in central Oregon. My husband and I lived at 10th & Jefferson for several decades, in a multi-unit building that we own and maintain as reasonable cost rental apartments. Please share any relevant experience that you feel prepares you for this position on the JWN board.

Serving as Vice-Chair for the past two years has given me a good grounding and overview in neighborhood challenges and concerns. I have also served as the board appointed liaison to the Neighborhood Leaders Council (NLC); a monthly meeting with one representative from each of the neighborhood associations in the city. Participating at the NLC level I have seen that JWN is one of the most active and effective neighborhood groups in the city. I have found ways to share information, interact and network with other neighborhoods to strengthen resources and participation in JWN. Owning and operating a business engaged in government relations at the Oregon Legislature, and working on behalf of businesses and advocacy groups in cities in other areas of the state has given me valuable experience working with individuals, groups and coalitions; helping to navigate through state, city and county bureaucracies.

What are the two main things you hope to accomplish in the coming year if elected to the JWN Board?

Continue to expand the number of neighbors who attend general meetings and encourage newer members to take leadership roles. Continue to facilitate more residents coming together on the JWN Disaster Preparedness Committee to facilitate individual, family and neighborhood planning and preparation for disasters. It is critical to get more people involved to safeguard neighborhood viability into the future.

What, if any, experience do you have working collaboratively in small groups?

For decades in Eugene I have been an advocate, elected official and/or volunteer who has served on many boards, commissions. I have worked and/or volunteered with various community-oriented advocacy groups. Previously I served for 10 years as an elected member of the Eugene Water & Electric Board. As part of the 5-member EWEB board I worked cooperatively to set the budget and policies that guided the largest municipal utility in Oregon. Currently I'm a volunteer with the League of Women Voters of Oregon Action Committee tracking, testifying and advocating on agricultural land issues in the Oregon legislature. I'm also a volunteer with several other organizations including the City Club of Eugene Programming Committee with 6 or 8 active members arranging speakers and coordinating programs on local and statewide issues, WOW Hall (Community Center for the Performing Arts), as well as an active member of several Tibetan Buddhist organizations. In all of these organizations I work cooperatively in small groups, including work groups on policy and document retention, and advocacy work on recycling, renewable energy, land use and zoning and other subject areas. I have experience and feel comfortable working with people from varied backgrounds and orientations. I'm willing and able to work with others to address mutual concerns and build stronger community ties.

At-Large Position #1

I've worked with families, caregivers, and interested community members as a Child Passenger Safety Technician and Instructor, teaching about car seats and vehicle safety. I've

I would also like to continue and expand the efforts already underway to promote neighborhood community and interconnectedness. The more we know our neighbors, the greater stake we have in working together and having a healthier, happier, more vibrant and supportive community.

What, if any, experience do you have working collaboratively in small groups?

I've often worked collaboratively with small groups. Working with a small, tightly knit group of other moms, we successfully remodeled an old house in which to start and run a nonprofit family resource center which provided child-centered information, classes and support groups to families in our community for many years.

Working as a Child Passenger Safety Technician Instructor for 14 years, I worked closely with a small group of 4-10 other Instructors to hold classes to train new technicians, small presentations to teach groups of caregivers the basics of car seat safety and large community events, working with both the instructors and technicians, to teach caregivers about car seat and vehicle safety. We also ran the regional Child Passenger Safety Team which, in addition to the above, wrote for and utilized grant funding to purchase car seats to distribute to low income families.

I've also held positions as an Assistant Manager, Shift Leader, and Restaurant Training Coordinator which all taught me to work collaboratively with my team of employees, in very fast paced environments, while training, encouraging and supporting the group so we could best serve our customers.
